
Editorial introductions

Nick Bouras



Nick Bouras, MD, PhD, FRCPsych, is Professor Emeritus of Psychiatry at the Institute of Psychiatry, King's College London, UK. He was also consultant psychiatrist, South at London and the Maudsley NHS Trust and director of the Estia Training and Research and Development Centre from 1982 to 2008. He has been a member of several national and inter-

national organisations including chairman of the World Psychiatric Association, Section of the Psychiatry of Mental Retardation, vice president of the European Association of Mental Health in Mental Retardation and vice president of the International Association for the Scientific Study of Intellectual Disability. His research is focused on health service-related topics, including assessment and clinical effectiveness of specialist mental health services, evaluation of multiprofessional training methods, and social and biological determinants of behaviour in psychiatric patients. He works as editor and member of the editorial boards of several journals. He has published extensively in community psychiatry and mental health aspects of people with intellectual disabilities. He is the co-editor of a Guide to Mental Health for Families and Carers of People with Intellectual Disabilities (2004), Mental Health in Learning Disabilities: A Training Resource (2005) and Psychiatric and *Behavioural Disorders in Developmental Disabilities and Mental Retardation* (2007).

Julio E. Arboleda-Flórez



Professor Julio E. Arboleda-Flórez, Canadian, born in Colombia, is a graduate of the Universidad Nacional de Bogotá, Colombia (1964). He did his studies in psychiatry at the University of Ottawa in 1970, and continued with studies in forensic psychiatry at the University of Toronto in 1971. He is a Fellow of the Royal College of Physician and Surgeons of Canada

(FRCPC, 1970) and has a Diploma from the American Board of Forensic Psychiatry (DABFP, 1979). In 1994, he obtained his PhD in epidemiology from the University of Calgary. Professor Arboleda-Flórez holds a Diplôme de Langue Française from the École Internationale de Langue et Civilization Françaises (Paris, 1984). He is a Member of the American College of Psychiatrists, Distinguished Life Fellow of the American Psychiatric Association; Fellow of the American College of Forensic Psychiatry and of the American Board of Forensic Examiners; Honorary Member of the World Psychiatric Association since 1993, Honorary Member of the Asociación Ecuatoriana de Psiquiatría since 1994 and Member Emeritus of the Forensic Department, Associaõ Brasileira de Psiquiatria since 1996.

Professor Arboleda-Flórez is a holder of a Rectoral Medal and is Honorary Professor at the Universidad de Chile; Adjunct Professor, Department of Psychiatry, University of Ottawa and Visiting Professor, Universidad del Bosque, Bogotá, Colombia. At present, he is Professor Emeritus at Queen's University, Canada.

Presently, Professor Arboleda-Flórez is President of the Canadian Academy of Psychiatric Epidemiology; Chairman, Forensic Section, Member of the Nominating Committee, Member of the Steering Committee for the Stigma Program and Zone 1 Representative to the World Psychiatric Associaton, Member of the Research Ethics Review Board of the Pan American Health Organization, Corresponding Member of the Ethics Committee of the American Psychiatric Association, and President of the World Association for Social Psychiatry. He is a Temprary Consultant for the World Health Organization, immediate past president of the International Academy of Law and Mental Health, and has been chairman of the Province of Ontario, Forensic Psychiatric Services Expert Advisory Panel and a member of the Ontario Review Board. He is on the editorial boards of national and international medical journals, Guest Editor on special topics at the *Canadian Journal of Psychiatry* and *Current Opinion in Psychiatry*, and he acts as reviewer for several research-granting bodies.

Professor Arboleda-Flórez is an international speaker, researcher on mental health services, psychiatric ethics and psychiatric epidemiology, author of books, multiple chapters and over 200 scientific papers and technical reports on mental health services, public mental health, mental health ethics, forensic psychiatry and psychiatric epidemiology.
